- 1. Bhajani Municipality, Office of Municipal Executive, Bhajani, Kailali has received grant from GON towards the cost of Hume Pipe supply and intends to apply part of the funds to cover eligible payments under the Contract for 03/2075/076. Bidding is open to all eligible Bidders from Nepal
- 2. The Bhajani Municipality, Office of Municipal Executive, Bhajani, Kailali invites sealed bids from eligible bidders for the procurement of hume pipe
- 3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Bhajani Municipality, Office of Municipal Executive, Bhajani, Kailali
- 4. A complete *set* of Bidding Documents may be purchased from the office Bhajani Municipality, Office of Municipal Executive, Bhajani, Kailali by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs Nrs 3000 till 9<sup>th</sup> Fagun 2075during office hours.
- 5. Pre-bid meeting shall be held at Bhajani Municipality, Office of Municipal Executive, Bhajani, Kailali at 2.00 PM of 27<sup>th</sup> Magh 2075.
- 6. Sealed bids must be submitted to the office Bhajani Municipality, Office of Municipal Executive, Bhajani, Kailali by hand/courier on or before 12.00 noon on 10<sup>th</sup> Fagun 2075. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2.00 PM 10<sup>th</sup> Fagun 2075 at the office of Bhajani Municipality ,Bhajani, Kailali. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security amounting to a minimum of NRs.1,00,000/-, which shall be valid for 30 days beyond the validity period of the bid i.e 8<sup>th</sup> Aasar 2076.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
