Invitation for Bids for the Construction of Mohanyal Secondary School Building in Bhajani Municipality.

- The Bhajani Municipality has allocated funds towards the cost of Construction of Mohanyal Secondary School Building
 in Bhajani Municipality and intends to apply part of the funds to cover eligible payments under the Contract for the
 Construction of Mohanyal Secondary School Building in Bhajani Municipality, contract
 nos: NCB/BM/BLDG/1/2078/079. Bidding is open to all eligible Nepalese bidders.
- 2. Bhajani Muncipality invites electronic bids from eligible bidders for the *construction of Mohanyal Secondary School Building in Bhajani Municipalit* under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs.3,26,83,800.00
- Minimum Work experience of similar size and nature: 1(one) project value of atleast NRs.2,95,00,000.00
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 5. Bidder must submit their bid electronically and should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the non-refundable fee of NRs.5000 bidding document in the Project's Rajaswa (revenue) account as specified below.

- Pre-bid meeting shall be held at Bhajani Municipality Office ,Bhajani 01,kailali at 15th December 2021,12pm.Last date for Purchasing of bid document is 26th december 2021,4PM.
- Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12 PM on 27th december,2021. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 27th december.2021,1 PM at the office of Bhajani Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of 9,22,110.00 [Nine Laks Twentytwo thousand one hundred ten rupees only], which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. The Employee reserve the right to accept or reject, wholly or partly any of all the bids without assigning any reason, whatsoever.
